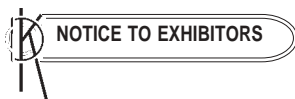

The Detroit Kennel Club, will provide two separate Multi-Breed Benching Sections for Professional Handlers with either a CPH, DHG, or a PHA Number, and Agent/Handlers with an MB-F Agent Number. Agents/Handlers not carrying an MB-F Agent Number are NOT ELIGIBLE to participate and will be assigned to the normal benching areas. NOTE: For those participating in the Multi-Breed Sections there will be **NO separate grooming areas**. All grooming will be done at the assigned benches. There will be **NO private exercise pens**. Exercise pens will be provided in the bench rows as well as large exercise pens at several locations. No owner or co-owner may be considered an agent. Agents under 18 years of age are not eligible.

1. A special index will be included in this Judging Program to help you locate your benching area. The Superintendent will provide name signs on benches and rows for quick identification of benching areas.
2. All handlers and agents will be permitted to have their grooming equipment only immediately within 5 ft. in front of their respective benches. There will be a 5 ft. aisle immediately beyond the 5 ft. space allocated for grooming equipment. This aisle is for public traffic control & fire safety regulations. 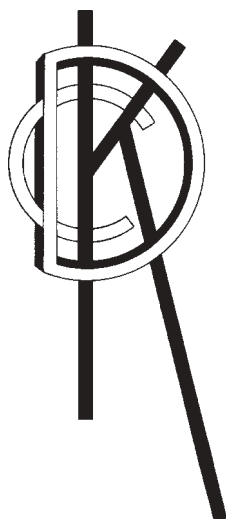

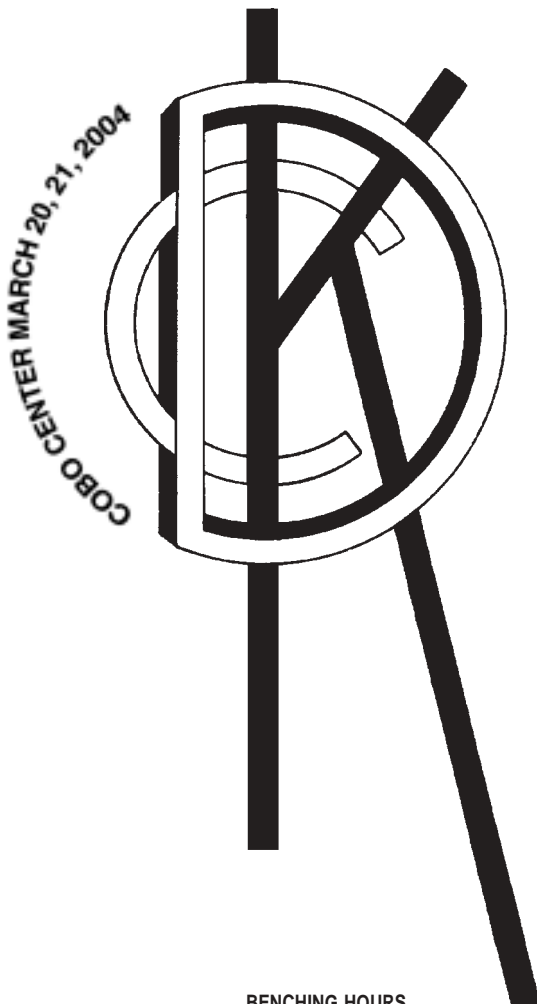
